

January 2021 YTD February 2021 Early Insights

Summary

January 2021

Key Takeaway: Zoo was closed from December 7, 2020, through January 28, 2021. Zoo was allowed to reopen effective January 29, 2021, with a capacity allowance of 1,800.

- \$191,424 self-generated revenue YTD (69% below budget)
- \$923,782 total expenses (27% below budget)
- (\$732,359) operating deficit (12% over budgeted deficit)
- (\$362,676) operating deficit with Measure Z support (49% over budgeted deficit)
- \$1,678,053 net surplus MZ Capital Funds, Depreciation, Investment Income/Interest


February 2021 Key Notes:

- PPP Loan 1 was forgiven for a total of \$1,715,621.80, including interest of \$12,921.86
- PPP Loan 2 was approved for \$1,853,770, funding received on 2/24/21
 - Submitted a proposed Measure Z Operating Budget amendment for approval by FZA Board to ensure no duplicate reimbursement of expenditures. No change in amount requested but will be shifting line items.
- Monthly attendance was approximately 148% of budget
- Preliminary self-generated revenue of YTD of approx. \$1,168,000 (11% below budget)
