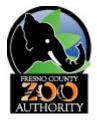



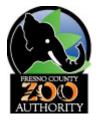

- CLR Design \$39,409.05 (\$29,912.52 + \$8,459.03 + \$1,037.50)

#### **DISCUSSION:**

In accordance with the Retention Policy Adopted September 30, 2015, and Revised January 30, 2019, retention of 5% was withheld on the Construction work provided by the above noted vendors, as related to the Kingdoms of Asia capital project.

Upon completion of a Fresno Chaffee Zoo project, the Zoo Corporation may request the release of any retention funds withheld for the project.

Prior to releasing any Retention Funds from the Escrow Account, ZooCorp shall request the release at an Authority Board meeting, at the same time presenting written certification that all conditions of the Escrow Agreement have been met, that the construction project is final and complete in accordance with the construction contract, and that the release of funds in the Escrow Account is appropriate. If applicable, such written certification shall include certification from the project architect or lead engineer that the project has been completed in accordance with the plans and specifications.

Note on CLR Design Invoices: At the January 19, 2023, meeting the ZooCorp Board approved a partial release of the CLR retention in the amount of \$29,912.52. This release was fully funded with ZooCorp operating funds and was not removed from the Measure Z Retention Escrow Account. As such, we are requesting a full release of \$39,409.05 of retention held on behalf of CLR Design in the Escrow Account, of which \$9,496.53 will be remitted to CLR Design and the remaining balance of \$29,912.52 will replenish ZooCorp operating funds.

Attached is a notice of completion on the Kingdoms of Asia exhibit and final retention releases totaling \$1,784,897.48.

Fresno's Chaffee Zoo Corporation Board of Directors approved this request at their meetings on January 19, 2023, September 26, 2023 and October 24, 2023.



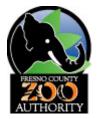

## **RECOMMENDED ACTION:**

# Approve transfer of \$280,119.28 in unspent funds allocated to Kingdoms of Asia Design to Kingdoms of Asia Construction.

## **DISCUSSION:**

Due to a number of factors (unprecedented inflation, global pandemic, supply chain issues, etc.), the Kingdoms of Asia exhibit construction costs will exceed the approved budget and Measure Z approved funding. Fresno's Chaffee Zoo Corporation management seeks approval to transfer unspent funds allocated for KOA Design to KOA Construction to cover the exhibit overages.

The total project construction budget approved by both the FCZ and FZA Board is \$38,365,323.98. To date the project has incurred costs of \$39,290,570.84. Additionally, we expect additional costs of approximately \$15,000 for project management expenses and \$7,000 in animal shipping to complete the project. This would bring the total project cost to \$39,312,70.84, resulting in project overages of \$947,246.86.

To offset these cost overages, FCZ management has negotiated a contribution from SSA, our concessionaire, of \$700,000.00 for construction costs related to the Longvek Marketplace café facility. That leaves \$247,246.86 in unfunded project overages. There remains \$280,119.28 in unspent funds approved by the Zoo Authority Board for Design work on Kingdoms of Asia. The Corporation's management is seeking approval to transfer the remaining \$280,119.28 in allocated Design Funds to the Construction Funds allocation to cover the remaining project overages. Unspent funds would then be returned to Measure Z upon final accounting closeout of the project, anticipated to be by the end of calendar year 2023.
