Key Takeaway: Zoo was open with no COVID-19 restrictions effective 6/15/21; As was indicated at start of Q2, there seems to be a waning trend in attendance; Special Events has suffered over the first half of the year due to COVID cancellations, expect to pick up ground as we come into the second half of the year

- \$9,463,931 self-generated revenue YTD (32% above budget)
- \$9,530,366 total expenses (5% below budget)
- \$66,434 operating deficit (less than budgeted deficit of \$2,834,236)

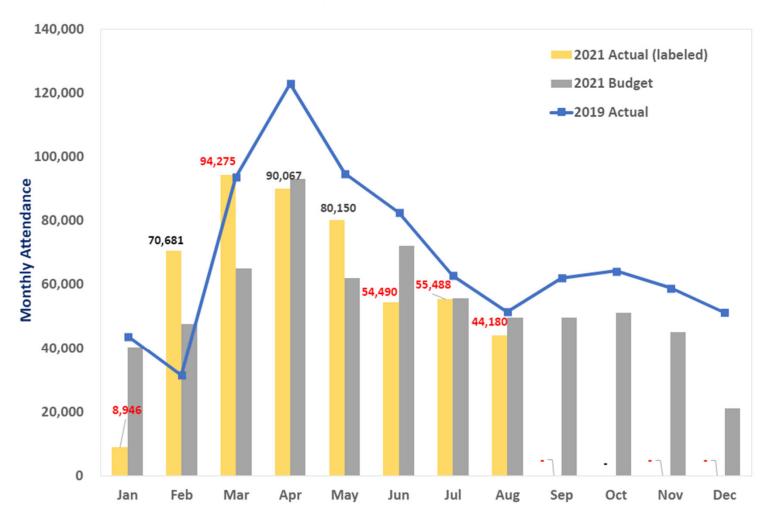

Renovation and Replacement of Superstructure, Chiller Addition

#### RECOMMENDED ACTION:

Approve Fresno Chaffee Zoo Corporation's request for Measure Z Capital funds totaling \$65,500 for the design phase of the trickling tower renovation and replacement superstructure along with the chiller addition.

#### DISCUSSION:

During an onsite inspection of Sea Lion Cove (SLC) in early Spring 2021 by the original contractors (Matt Construction) to evaluate corrosion issues identified in certain portions of SLC, it was determined that the biotank filtration tower walls were experiencing substantial corrosion issues that may compromise the long-term integrity of the structure. It was recommended by Matt Construction that the best course of action is to conduct a major demolition and replacement operation to large sections of the tower walls to restore its long-term service life.

The Fresno Chaffee Zoo Corporation is requesting funding to move forward with the demolition and replacement work on the biotank filtration tower walls. The mobilization and work of this project creates the optimal time to complete the necessary work for electrical components and chillers to provide sufficient chilling capacity for our pool, as described below.

SLC was originally completed without the chilling capacity necessary to keep the water temperatures within husbandry standards set forth by the Alliance of Marine Mammal Parks and Aquariums and USDA. In 2015, the Zoo invested in a swamp cooler mechanism to facilitate the cooling of the waters, but this has not proved sufficient to maintain the water temperatures at the ideal parameters for this species.

The proposal from Lawrence Engineering Group is from design inception through the plan check approval. Preliminary estimates on the overall project cost from design through construction completion are approximately \$610,000. However, at this time are requesting only the design portion of the project.

The Fresno Chaffee Zoo Corporation Board of Directors approved this request on September 9, 2021.
